Is there radioactive material in our ocean?

As a result of the earthquake and tsunami at Fukushima and the ongoing releases of radioactive material into the ocean, Mothers for Peace continues to fund the efforts to answer this question. We provide periodic samples of ocean water off Pismo Beach to Woods Hole Oceanographic Institution for analysis. Thus far, no radiation from Fukushima has been detected in our local waters.

California Public Utilities Commission Update

The "Joint Proposal" was developed to shut down Diablo Canyon Nuclear Power Plant by 2025 and replace it with energy efficiency, renewable energy, and other GHG-free resources. Mothers for Peace has been working towards earlier closure.



We urge you to email the CPUC and communicate your concerns and

questions regarding the Joint Proposal: safety, seismic risk, future land use, economic impacts, insecure workforce, and marine degradation. Encourage the CPUC to order PG&E to close the two reactors by 2019.
